Communication No. 5 – January 2023

Must be read at the first meeting following receipt, before being filed for reference.

1. Sec 103 – Notification and Obligation (pg. 14)

When an applicant has been accepted by vote of the Auxiliary, they shall be notified orally or in writing that their application has been accepted. The Auxiliary Secretary shall notify the newly elected member to appear at a state time to receive the ceremonial obligation.

In the event the newly accepted member has subscribed to the printed obligation on the application, they shall be considered a member in good standing as soon as elected and shall thereafter be entitled to all the rights and privileges of a member including election to an office. The newly accepted member shall not be required to take the ceremonial oral obligation.

If the applicant is obligated at any time after July 1, the dues paid shall be for the next succeeding calendar year. The new member shall receive from the Auxiliary a membership pin and a copy of the "Podium Edition.

NOTE – The Treasurer and the person recommending the new member **SHOULD NOT** be part of the investigating committee!

2. Sec. 104 – Members in Good Standing (pg. 15):

The membership year of the Auxiliary is from January 1 to December 31. A member who has paid their dues to December 31 is in good standing. A member ceases to be in good standing on January 1 immediately following the year for which dues have been paid. A member shall not again be in good standing until their dues have been paid for the current year. Continuous membership begins again upon payment of dues. Dues must be paid by June 30 to remain a continuous member. Prior year's dues may not be paid after July 1.

Any member who has not maintained continuous membership shall submit an application and be accepted in the same manner as a new member. No admission fee shall be required. Date of rejoin starts new continuous membership timeline.

3. Sec. 916– Rules of Order (pg. 96)

Rules for governing the conduct of meetings for the Auxiliary shall be as prescribed in the Ritual. *Robert's Rules of Order, Newly Revised* shall govern on all points not covered in these Bylaws.

Please remember that Section 103 states, "The new member shall receive from the Auxiliary a membership pin and a copy of the "Podium Edition." There are several Auxiliaries that are not doing this. Most are charging the \$5 that was in the last podium edition before it was updated at the National Convention in Kansas City. HOWEVER the new bylaws states on page 12: Admission fee fixed by the Auxiliary to be paid when initially joining, which entitles each new member to a membership pin and a copy of the current "Podium Edition Bylaws and Ritual." The cost of a membership pin is \$3 and the cost of the book is \$7.25. Any members that have joined need to be given these. You can make a standing rule for your admission fee based on these costs.

Our membership at this point is 93.44%. A lot of dues are being processed for the end of December so we are hoping for the goal of 95% on December 31st. We need 99 members or reach that. For the past 2 years we have been 100% at our Spring Conference so let's not break that chain. Let's get those dues in!!!

Hopefully all reports were turned in by December 1st. Remember that you do not have to do these in a group at a meeting. Chairman may do these themselves. Perhaps at meetings people can talk about what they have done so that the chairmen can make notes for their reports. Everyone's input is always good!
